## \*CLASSES OF MEMBERSHIP

**Full Member:** A Full Member must be the owner or co-owner of an Austin 7 or a vehicle which complies with any Club Formula. There is a limit of two co-owners per vehicle.

**Family Subscription:** A Family Subscription covers one Full Member, Spouse and Juniors (Children or Grandchildren).

**Associate Member:** An Associate Member includes all other persons interested in the Club. Associate Members are not entitled to vote at any Club Meetings.

Associate Membership includes the following;-

**Spouse Associate Member:** Any Full Member may nominate one Spouse Associate Member as part of a Family Subscription.

**Junior Associate Member:** Any Full Member may nominate their children or grandchildren as Junior Associate Members as part of a Family Subscription if they are aged under 21 years old and are dependant children. Date of birth must be provided.

**Observed Section Trial Passenger Associate Member:** A person being solely involved in the Club as an O.S.T. Passenger may be admitted as an O.S.T. Passenger Associate Member.

**Club Associate** – Is another incorporated association that has similar objects to the Club.

**Other Information:** A Motorsport Australia Level 1 or Level 2 Competition Licence is required by Members who participate as drivers in competitive Club events such as O.S.T. and Motorkhanas. These are available on-line from Motorsport Australia.

**Working With Children Check:** The Working with Children Act requires adults regularly involved in community volunteer activities, where children are present, to undergo the working with children check. Event managers of activities run by the Austin 7 Club are required to ensure staff have the appropriate checks.
